

1. PHOTO LIBRARY USERS

Access to the photo library is restricted to individuals wishing to promote the Fondation pour la Culture et les Civilisations du Vin and La Cité du Vin for communication and/or promotion purposes only. Use for commercial or advertising purposes is not permitted.

The visuals made available by the Fondation pour la Culture et les Civilisations du Vin are the property of their author or their beneficiaries. As a result, photo library users are not granted any reproduction rights.

This right of use is then defined in more detail according to the major user categories defined:

- Press and blogs. Visuals are made available to the press and blogs to promote the Fondation pour la Culture et les Civilisations du Vin and/or La Cité du Vin, excluding the front or back covers of print copy and excluding commercialised tourist guidebooks or publishing houses. The article including the visual may be shared on social media under the conditions set out below.

- Institutional and tourist organisations. Visuals are made available to illustrate communication materials and online media (social media, websites), excluding poster campaigns. Use for commercial purposes is not permitted.

2. RIGHTS & CONDITIONS OF USE

Single use

Upon request, photos are loaned for a single specified use and may not under any circumstances be re-used for reasons other than those declared. Any new use will require a new application to be made. Finally, photos may not be passed on to any third parties without prior authorisation.

Sending proof of publication

These general terms and conditions of use are governed by the law in force in France. Any usage which does not comply with the general terms and conditions of use of the La Cité du Vin photo library will be subject to legal proceedings before the competent courts.

These general terms and conditions of use and restrictions are subject to change. The user must be sure to read and take note of them before each use.

4. LIMITATION OF LIABILITY

Users are granted open access to the photo library.

The photo library user undertakes to use the visuals in accordance with these terms and conditions, and in the event of any non-compliant or prohibited use, they shall indemnify the Fondation pour la Culture et les Civilisations du Vin against any suits, legal proceedings, claims or demands from any person relating to such use of the visuals.

When they borrow one or more visuals, the user undertakes to take liability and indemnify the Fondation pour la Culture et les Civilisations du Vin in the event of any suits, legal proceedings, claims or demands relating to non-compliant or prohibited use of visuals under the terms of this contract.
